Programme of your Institution under The West Bengal University of Teachers' Training, Education Planning and Administration for the academic year 2021-2022 subject to the fulfillment of the following terms and conditions:

1. The college shall be guided by the NCTE Regulations 2014 in respect of appointment of teaching and non-teaching staff, purchase of books, audio-visual material and automation of the library.
2. The college will continue to organize and equip the laboratories as per stipulation of NCTE. Other infrastructure are to be maintained as per NCTE norms.
3. The said college shall be obliged to follow the fee structure and other terms and conditions specified by the State Government /Competent Authority under NCTE regulations from time to time. Appropriate action shall be taken if any irregularities are found in this regard.
4. Intake capacity will be 100 as per NCTE norms considering the present situation 100 students should be admitted for the academic session 2021-23.
5. Appointment of faculty already done/ to be done in future and their pay and allowances must follow the latest NCTE, UGC and State govt. norms. Payment of salary must be through proper procedure directed by the Govt.



6. In respect of maintenance of academic and financial discipline the college will strictly follow norms of NCTE (in strict observance of the latest notification)/State Government Orders issued from time to time and relevant conditions/rules of the Affiliating University in this regard especially with respect to the minimum number of teaching days in an academic session as stipulated by the Affiliating University/NCTE.
7. Expert(s), duly authorized by the University may make 'surprise visit' to the college for rapid, on-spot assessment of the quality of functioning. If any short-fall / discrepancy is identified by the Inspection Team, affiliation of the programme may be withdrawn.
8. The college authority shall abide by the Acts, Statutes, Regulations etc. of this University as are in force or as may be amended from time to time.
9. Admission of students will be as per norms stipulated by the University.
10. Staying in the college hostel, if any, is not mandatory for the students.
11. The Governing Body of the College is to be constituted as per provisions of the State Govt. / Affiliating University.
12. The following school subjects are approved as Pedagogy subjects for curriculum transaction at your college along with other foundation courses and optional courses, if any :  
**Bengali, English, Geography, History, Life Science, Mathematics, Physical Science, Sanskrit, Fine Arts, Political Science, Philosophy, Education, Sociology, Music**
13. This affiliation to be renewed per year.
14. Fees structure for B.Ed. programme will be fixed up by the NCTE Norms & Higher Education Department, Govt. of West Bengal.
